**LETTER OF DEMAND**

We are instructed by our client that in the year 1999 yourself, Mr. Rohitha Jayalath and our client formed a Musical Band called "ජය ඉ" and subsequently it was registered at **AKM & austro mechana**, at **Vienna** where the Copyrights of the "ජය ඉ" products are vested in all in equal share.

We are instructed by our client that with the contribution of our client, and you and Rohitha Jayalath had produced and directed many Songs and our client is the Lyricist, Musician and Vocalist of many of the popular songs album titled "මෙහි ගෙවිලා" and "සුන්දරිය" which songs were sung by our client, you and Mr. Rohitha Jayalath.

We are instructed by our client that you and Mr. Rohitha Jayalath without the consent of our client who is a co-owner of the Copyrights of all products made by “ජය ශ්‍රී” band have unlawfully in a violation of the provisions contained in the Intellectual Property Act, No. 36 of 2003, have assigned, sold, remixed, and misused.
